h) SS EDUCATIONAL SERVICES may seek assistance/guidance of ACEE faculty member/s in product/process modification, modernization, trouble shooting, etc.

## ARTICLE-III: SHARING OF FACILITIES

- a) ACEE and S S EDUCATIONAL SERVICES shall make provisions to share their respective important R&D facilities in order to promote academic and research interaction in the areas of cooperation.
- b) ACEE and SS EDUCATIONAL SERVICES shall permit the sharing software and other materials and components developed in-house in the areas of cooperation, if permissible within the rules governing the two institutions.
